Re: Sole Source recommendation for Purvis Systems Inc.

Dear County Judge and Commissioners,

Recently our county Emergency Communications department made a request for qualifying the sole source purchase of Purvis Fire Station Alert Monitoring System (PURVIS FSAS) hardware, software and services. The PURVIS FSAS was procured by Williamson County using competitive bid Process RFP #15RFP115 in 2015. Now there is a need for additional hardware, software and services associated with this original purchase. The design and software for the PURVIS FSAS is propriety and is not marketed, serviced, or resold by any other entity.

After reviewing all documentation requested and submitted, I recommend qualifying this request as a sole source purchase per Texas Local Government Code sections 262.003 (a) and 262.024 (a) (7).

The process has included the following:

- Public posting of an RFI in BidSync for 14 days, with no responses received from any other competitor, requiring additional analysis or consideration.
- A signed Sole Source Justification Request submitted by Terry Purvis, Public Safety Tech. Mgr.
- A signed letter of justification from the supplier, establishing why they their product / service is only available from their company
- A notarized Sole Source Affidavit completed by the supplier
- A signed letter of recommendation from Scott Parker, Director of Emergency Communications
- A price list of potential additionally needed items.
- A notarized Certificate of Interested Parties (Form 1295) as required by the Texas Ethics Commission.

The term of this Sole Source exemption will be effective for 60 months from the date of approval.
