

AMENDMENT TO DEVELOPMENT AGREEMENT
REGARDING DETENTION POND

This document is an amendment (the "Amendment") to the Development Agreement Regarding Detention Pond (the "Agreement") entered into by and between Williamson County, a political subdivision of the State of Texas ("County") and Gardens at Mayfield LLC, a limited liability company organized under the laws of the State of Mississippi ("Developer") that is dated June 6, 2016.

For and in consideration of the mutual promises contained in the Agreement and other good and valuable consideration, the receipt and sufficiency of which is acknowledged, the parties agree as follows:

1. Paragraph C (1) is deleted in its entirety and replaced with the following:

"C (1). Developer agrees to construct the Project. The Project has an estimated cost of the amount set out on Exhibit B attached."

2. Paragraph D (1) is deleted in its entirety and replaced with the following:

"D (1). County agrees to pay to Developer as a reimbursement of construction and design costs, \$221,471.57, on or before ten (10) days from the date of this Amendment. County agrees to reimburse Developer for the balance of the total cost of the Project, minus the Developer's contribution of \$26,688, on or before thirty (30) days after final invoice for construction of the Project is presented to the County."

3. Exhibits A and B are deleted and replaced with the Exhibits A and B attached to this Amendment.

4. There are no other or further modifications or amendments to the Agreement. The parties ratify and affirm all provisions of the Agreement as modified by the Amendment, and acknowledge that the Agreement as Amended is an effective and existing obligation and contract between the parties.

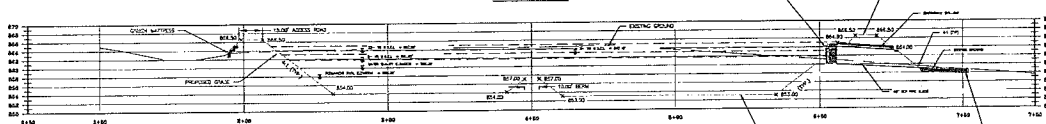

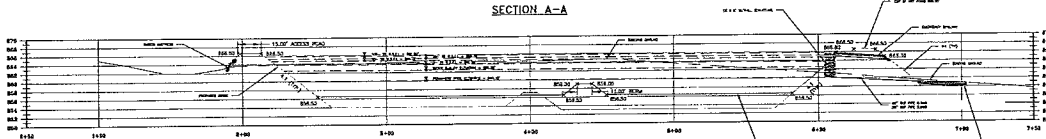

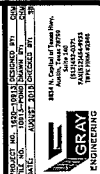
SECTION FOR THE ORIGINAL WET POND AS PER THE

SECTION A-A

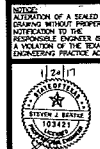
