

**ORDER ADJUSTING THE BOUNDARY BETWEEN  
WILLIAMSON COUNTY ELECTION PRECINCTS 206, 207, AND 267**

Precinct 207 has 4,870 active registered voters. Precinct 207 is approaching violation of section 42.006 of the Texas Election Code stating a precinct cannot contain more than 5,000 active registered voters. Section 42.031(b)(2) of the Texas Election Code grants Commissioners Court the authority to make necessary changes in the precinct boundary.

The precincts affected by the boundary adjustments are 206, 207, and 267 and graphically shown in the map described as Exhibit "A," attached hereto and incorporated herein. The changes will result in the following active registered voter counts:

Precinct 207	4,202
Precinct 206	2,727
Precinct 267	3,139

NOW, THEREFORE, BE IT ORDERED that, effective January 1, 2018:

**Precinct 267** will gain the southeastern portion of current Precinct 207, east of US Highway 183. The precinct will also gain the northeast portion of current Precinct 206, east of US Highway 183. The designated polling place for Precinct 207 shall remain Liberty Hill High School, 16500 W State Highway 29, Liberty Hill. The designated polling place for Precinct 267 remains combined with Precinct 264 Pat Bryson Municipal Hall, 201 North Brushy Street, Leander.

Election Precinct No. 206  
Williamson County, Texas

BEGINNING at the intersection of West State Highway 29 and the common line between Williamson and Travis County;

THENCE, easterly, along the center of West State Highway 29 to its intersection with the center of Northbound US Highway 183;

THENCE, southerly, along the center of Northbound US highway 183 to its intersection with the center of County Road 263;

THENCE, westerly, along the center of County Road 263 to its intersection with the center of Metrorail Track;

THENCE, southerly, along the center of Metrorail Track to the southern boundary of Census Block 484910203013059;

THENCE, westerly, along said boundary to the southern boundary of Census Block 484910203013089;

THENCE, westerly, along said boundary to the northern boundary of Census Block 484910203013091;

THENCE, westerly, along said boundary to its western border;

THENCE, southerly, along the western boundary to the northern boundary of Census Block 484910203142022;

THENCE, southerly, along the center of US Highway 183 to its intersection with the center of West State Highway 29;

THENCE, westerly, along State Highway 29 to its intersection with the common line between Williamson and Travis Counties.

THENCE, westerly, along the center of Hero Way to the eastern boundary of Census Block 484910203021035;

THENCE, southerly, along said boundary to the southern boundary of Census Block 48491020321053;

THENCE, westerly, along said boundary to the southern boundary of Census Block 484910203021035;

THENCE, westerly, along said boundary to County Road 269;

THENCE, northerly, along the center of County Road 269 to the western boundary of Census Block 484910203021015;

THENCE, northerly, along said boundary to the western boundary of Census Block 484910203021003;

THENCE, northerly, along the western boundary to its northern boundary;

THENCE, easterly, along said boundary to County Road 270;

THENCE, northerly, along the center of County Road 270 to the southern boundary of Census Block 484910203021019;

THENCE, westerly, along said boundary to its western boundary;

THENCE, northerly, along said boundary to the center of Private Road 918;

THENCE, easterly, along the center of Private Road 918 to its intersection with the center of County Road 270;

THENCE, northerly, along the center of County Road 270 to the southern boundary of Census Block 484910203021021;

THENCE, westerly, along said boundary to its western boundary;

THENCE, northerly, along said boundary to the western boundary of Census Block 484910203021009;

THENCE, northerly, along said boundary to the center of South Fork San Gabriel River;

THENCE, westerly, along the center of South Fork San Gabriel River to the western boundary of City of Leander;

THENCE, southerly, along the western boundary to its intersection with Metrorail Track;

THENCE, westerly, along Metrorail Track to the western boundary of City of Leander;

THENCE, southerly, along said boundary to Heritage Grove Road;

THENCE, westerly, along the center of Heritage Grove Road to its intersection with the center of Oak Grove Road;

THENCE, northerly, along the center of Oak Grove Road to the southern boundary of Census Block 484910203142026;

THENCE, westerly, along said boundary to the western boundary of Census Block 484910203142026;

THENCE, northerly, along said boundary to the western boundary of Census Block 484910203142022;

THENCE, northerly, along said boundary to the northern boundary of Census Block 484910203142022;

THENCE, westerly, along said boundary to the western boundary of Census Block 484910203013091;

THENCE, northerly, along said boundary to northern boundary of Census Block 484910203013090;

THENCE, easterly, along said boundary to the Metrorail Track;

THENCE, northerly, along the center of the Metrorail Track to its intersection with the center of County Road 263;
