ORDER CREATING WILLIAMSON COUNTY ELECTION PRECINCT 263

Precinct 253 has 5,309 active registered voters. Precinct 259 has 5,630 active registered voters. Precincts 253 and 259 violate section 42.006 of the Texas Election Code because it they contain more than 5,000 registered voters. Section 42.031(b)(2) of the Texas Election Code grants Commissioners Court the authority to make necessary changes in the precinct boundary.

Recommendation is made to split Precincts 259 and 253 to create Precinct 263 as graphically shown in the map described as Exhibit "A," attached hereto and incorporated herein. The creation will result in the following active registered voter counts:

Precinct 253	4,189
Precinct 259	3,274
Precinct 264	4,058
Precinct 263	3,613

NOW, THEREFORE, BE IT ORDERED that, effective January 1, 2018:

Precinct 263 shall be created from the northwest portion of current <u>Precinct 253</u>, north of Crystal Falls Parkway. The precinct will also gain the southern portion of current <u>Precinct 259</u>, south of Old 2243 West. The designated polling place for Precinct 263 shall be Leander Public Library, 1011 South Bagdad Road, Leander.

Precinct 259 will gain the northern portion of <u>Precinct 264</u>, north of Old 2243 West. The designated polling place for Precinct 259 shall remain Pat Bryson Municipal Hall, 201 North Brushy Street, Leander. The designated polling place for Precinct 259 shall be Bagdad Elementary School, 800 Deercreek Lane, Leander.

Precinct 264 will gain a portion of <u>Precinct 259</u>, south of Old 2243 West. The designated polling place for Precinct 264 shall remain Pat Bryson Municipal Hall, 201 North Brushy Street, Leander.
