ORDER CREATING WILLIAMSON COUNTY ELECTION PRECINCT 345

Precinct 343 has 5,085 active registered voters. Precinct 343 violates section 42.006 of the Texas Election Code because it contains more than 5,000 registered voters. Section 42.031(b)(2) of the Texas Election Code grants Commissioners Court the authority to make necessary changes in the precinct boundary.

Recommendation is made to split Precinct 343 and create Precinct 345 as graphically shown in the map described as Exhibit "A," attached hereto and incorporated herein. The creation will result in the following active registered voter counts:

Precinct 343 3,228
Precinct 345 1,861
Precinct 342 929

NOW, THEREFORE, BE IT ORDERED that, effective January 1, 2018:

Precinct 345 shall be created from the western portion of current <u>Precinct 343</u>, following the current Georgetown ISD boundary from State Highway 29 to the boundary of State Representative District 20. The designated polling place for Precinct 345 shall be Rancho Sienna Elementary School, 751 Bonnet Boulevard, Georgetown. The designated polling place for Precinct 343 shall remain First Baptist Church, 1333 West University Boulevard, Georgetown.

Precinct 343 will gain the portions of current <u>Precinct 342</u>, not within current Georgetown Single-Member District 1 boundary. The designated polling place for Precinct 342 shall remain The Caring Place Annex, 2001 Railroad Avenue, Georgetown.
