ORDER CREATING WILLIAMSON COUNTY ELECTION PRECINCT 393

Precinct 394 has 5,826 active registered voters. Precinct 394 violates section 42.006 of the Texas Election Code because it contains more than 5,000 registered voters. Section 42.031(b)(2) of the Texas Election Code grants Commissioners Court the authority to make necessary changes in the precinct boundary.

Recommendation is made to split Precinct 394 and create Precinct 393 as graphically shown in the map described as Exhibit "A," attached hereto and incorporated herein. The creation will result in the following active registered voter counts:

Precinct 381	3,182
Precinct 393	2,248
Precinct 394	3,598
Precinct 396	3,396

NOW, THEREFORE, BE IT ORDERED that, effective January 1, 2018:

Precinct 393 shall be created from the southwest portion of current <u>Precinct 394</u> southeast of Berry Creek. The designated polling place for Precinct 393 shall be Legacy at Georgetown, 4907 Williams Drive, Georgetown.

Precinct 381 will gain the portion of current <u>Precinct 396</u> not within the boundary of Jarrell Independent School District. The designated polling place for Precinct 381 shall remain Sun City Social Center, 2 Texas Drive, Georgetown.

Precinct 396 will gain the portion of current <u>Precinct 381</u> not within the boundary of Georgetown Independent School District. The designated polling place for Precinct 396 shall remain The Worship Place, 811 Sun City Boulevard, Georgetown.
