In response to Solicitation #1711-205 the Purchasing Department received complete Bid Tabulations from one (1) company desiring to provide Concessionaire Services for Williamson County Exposition Center.

The Expo RFP Evaluation Committee, with Purchasing Department overview, evaluated the Bid Tabulations according to the criteria contained in the Solicitation:

- 1. Percentage of gross sales after taxes
- 2. Three (3) commercial references for similar services in the past three (3) years.
- 3. Local Presence/ Local Representation
- 4. Experience overall in concessions business of like size and type
- 5. Equipment to be used in the facility
- 6. Sample menu with proposed prices
- 7. Staffing for all events
- 8. Experience associated with start-up operations

After evaluating all Bid Tabulations according to the stated criteria, and considering the best and final pricing offer of 20% commission on all Net Sales (Gross Sales Less Sales Tax) for the duration of the contract of gross sales to be paid back to the County, Heartland Food Group is the best overall selection for Concessionaire Services for Williamson County Exposition Center.
