

AMENDMENT

This amendment ("Amendment") is made as of the date of last signature below (the "Amendment Effective Date") by and between Tyler Technologies, Inc. ("Tyler") and Williamson County, Texas ("End User").

WHEREAS, Tyler and End User are parties to that certain End User License Agreement and Professional Services Agreement dated September 14, 2011 (the "Agreement"); and

WHEREAS, Tyler and End User desire to amend the Agreement in certain respects as further set forth herein.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and End User agree as follows:

1. The Licensed Software detailed in the attached Amendment Exhibit A is hereby added to the Agreement. Upon the Amendment Effective Date, End User shall pay Tyler the License Fees for the Licensed Software added hereby.
2. Upon the Amendment Effective Date, the Licensed Software added hereby shall become subject to the current Maintenance and Support Services Agreement and End User shall pay the Maintenance and Support Fees detailed on the attached Amendment Exhibit A on a prorated basis through the end of End User's current term, and thereafter, annually in advance in accordance with the current Maintenance and Support Services Agreement.
3. The Professional Services detailed in the attached Amendment Exhibit A are hereby added to the Agreement. Professional Services fees shall be invoiced to End User as delivered, on a time and materials basis.
4. Tyler shall invoice End User for travel expenses as such expenses are incurred.
5. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement.
6. All other terms and conditions of the Agreement shall remain in full force and effect. Except as defined herein or otherwise required by the context herein, all defined terms used in this Amendment have the meaning set forth in the Agreement.
