This letter will serve as the first amendment the contract between Crisis Track and the Williamson County Texas entered into as of 3/20/2017. The amendment will change the following items:


1. This amendment will change the product description and offering in Exhibit A from CTDM14 Disaster Management to CTEM15 All-Hazards Emergency Management
