




LOOK BACK ROLLING 12 MEDICAL CLAIMS




PAST COVERAGE LEVEL (PCL) MEDICAL



LOOK-BACK ROLLING 12 RX CLAIMS




PAST COVERAGE LEVEL (PCL) RX
