

INTERLOCAL AGREEMENT

Pursuant to Texas Government Code, Chapter 791, the Williamson County Road & Bridge, acting by and through Williamson County, Texas ("Williamson County"), wishes to enter into an Interlocal Agreement ("Agreement") with Burnet County, Texas ("Burnet County"), to improve the roadway of BRNT CR 322 within the limits of Williamson County.

A description of the services to be performed, location of work site and the estimate of cost is attached hereto as Exhibit "A" and incorporated herein by reference.

Upon completion of the services described in Exhibit "A", Burnet County shall invoice Williamson County for the total actual costs of all material, labor and equipment used to perform the services. Williamson County shall pay Burnet County within thirty (30) calendar days from the date of the invoice.



Burnet County will improve the section of BRNT CR 322 inside Williamson County, from the Burnet County Line to SH 29, with the same construction application as Burnet County will be performing on its portion of BRNT CR 322.

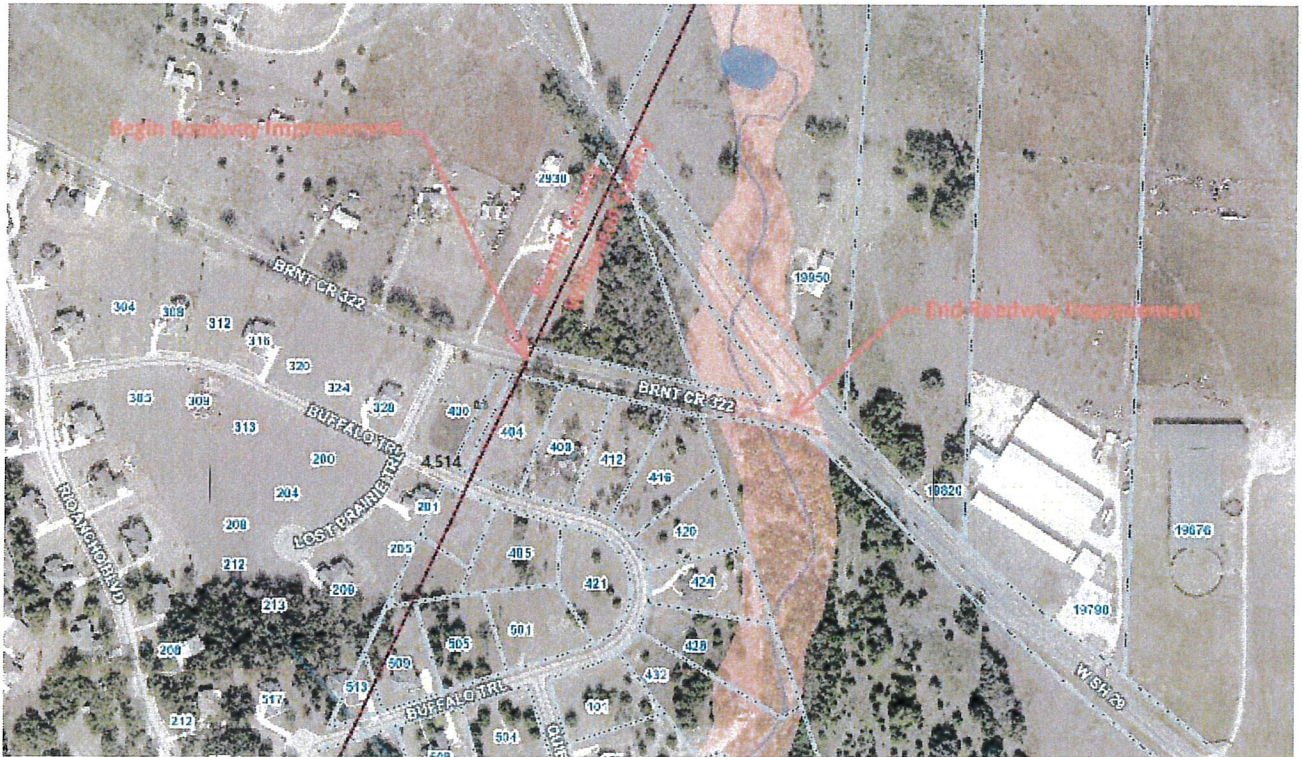
The preliminary plan sheet of the work proposed is attached hereto as Figure 2, Sheet 5.3.
