#### SCOPE:

Furnish and install all materials, tools and labor required for the following scopes of work:

### 1. Change Event #09: PEC - Underground Electric

\$406,246.00

Furnish and install primary conduit and sectionalizing cabinets per PEC Underground Primary PDF dated 10-4-19

#### Inclusions:

- Cut, back-fill and compact 8,625 L.F. of primary trench
- Furnish and install 8,625 L.F. of primary conduit
- Furnish and install (15) primary sectionalizing cabinets
- Furnish and install (19) pads
- Revegetate disturbed areas
- Road sleeves
- New service rack w/ 200amp meter and fused disconnect at Day Use Pavilion
- Temporary powered to permanent fixtures for finishes
- L.F. of trench and conduit not to exceed amount shown in this change order; L.F. to be field verified upon completion

### Exclusions:

- Primary wire
- PEC expenses
- Removal of existing pole
- Pole riser with weather head

- Stub up conduit for push button station
- Stub up conduit for (2) photo eyes
- Pull and terminate wire

### 3. Change Event #047: Owner Credit – Water Meters, Type J Signage

Provide credit for all water meters and type J signage

### **Inclusions:**

- Bid Item 107: Site Marker Trails, including post and footing
- Bid Item 148: 1 1/2" Water Meter (Irrigation)
- Bid Item 149: 1" Water Meter (Irrigation)
- Bid Item 164: 1" Water Meter (Domestic)
- Bid Item 165: 5/8" Water Meter (Domestic)

This Change Order shall constitute full and final negotiations for the said scope of work with no assumptions, additional obligations, or promises made other than what is strictly written within this document.
