Scope of Work

MAIN RENOVATIONS

- Demo existing screen, projector, and installed equipment
- Install 108" diagonal motorized screen with Oak case
- Install Laser Projector, WUXGA, 5,000 Lumen
- Install revised Crestron video switching equipment and input devices in podium and under counter
- Install 2 new 7" table top mounted touch panels
- Full reprogram of system, retaining basic functions that exist and upgrading functionality where needed.
- Install new Owner Furnished, Contractor Installed PTZ Camera and interface to Owner Furnished Swagit System
- Install new gooseneck mic at podium with mute switch
- Test and repair all microphone input pockets.
- Install new Assistive Listening System for each room. Includes ADA-compliant quantity of devices
- Install 3 handheld wireless microphone systems
- Install new Digital Signal Processors for audio routing and functionality
- Install new amplifiers for speaker zones
- Training and familiarization time provided

Decorum Display in Conference Room

- Install one 55" Flat Panel Display
- Install support structure and pole mount
- Mount Owner Furnished Novo Wireless device
- Add Electric Service for display and Wireless Device

- For the main renovations, the court chambers will need to be closed for one week
