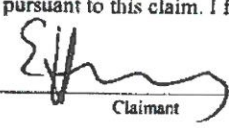
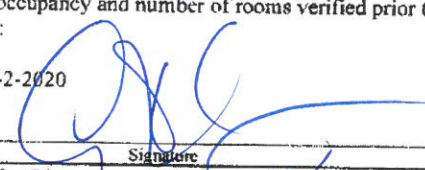

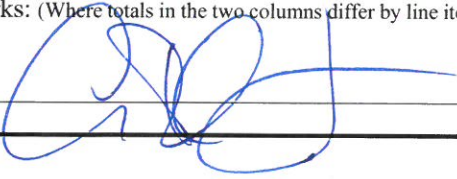

Bedroom: bed, bedside table, clothes, suitcases, two helmets, carpet, large wardrobe for supplies. Bedsheets and blankets.

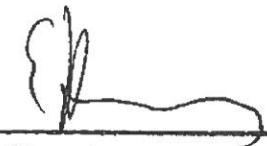
Laundry room: organizers, food overflow, Washer, dryer, drying rack, a dress dummy, antique school desk with chair, dry sink with decorations.

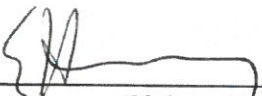
