Lisa, Hi

See email below along with the attached invoice that I received from Elizabeth Henning, parcel 81 on SE Loop. This is for the power pole that was relocated to provide electricity to her remainder where she moved her home. This is the cost that we discussed previously, that she is wanting reimbursement.

Moving costs cover charges that a utility may impose for the transfer of services from the displacement address to the replacement address. The cost to reestablish electricity on the remainder where she moved her house is not a typical moving cost, this cost could be paid as part of her replacement housing supplement provided she met the price requirements to qualify for a supplement, but in her case because she negotiated a higher acquisition price her supplement was reduced to zero.

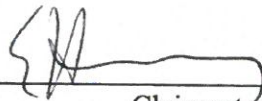
