

My apologies for not getting back to you, I was gathering information to respond. Please see below responses.

1. Storage Shed Moving – \$3,081.25

On March 19, 2019 I spoke with Tom and emailed them including you that the County would not reimburse for the purchase of permanent storage. See attached email.

The regulations allow for "temporary" storage up to 12 months and must receive prior approval before expending funds.

On March 19, 2019 I called Steel Box Containers and was informed the cost to RENT a unit of the same size was \$100 / month.

The County would reimburse up to 12 months at \$100/ month which equals \$1,200 for storage.

- 2. Moving Storage Shed -\$510.00 Please furnish a paid receipt from the transport company used to relocate the shed for us to process the claim.
- 3. Cost of moving Portable Livestock Shed \$200.00 this will be processed for payment.
- 4. Cars being relocated from the subject site I have arranged for a moving company to relocate the cars as a direct payment to vendor. Hi Rhonda, Laurie and Mylan,

My clients, Thomas and Melissa Diaz, are not clear on the checks they have received for relocation benefits. They have received the following checks:

- 1. \$4400.00 closing costs
- 2. \$2050 not sure for what expenses?;
- 3. \$992.00 not sure for what expenses?

We would like an itemized statement or detail of the expenses that have been reimbursed. I know they are entitled to the housing supplement, closing costs, moving costs, interest differential payment and actual incidental costs.

My client has provided you with the invoices and information for all the expenses they should be reimbursed for but it is their belief that they have not received payment for all items. Therefore, please provide us an itemized statement of all the costs/ expenses paid for relocation to the present date.

In addition, under the relocation program, they are entitled to a housing supplement \$158,632 for the purchase of their replacement home (price differential payment). To the present date, they have not received this supplement. As stated in many emails from you (Rhonda) and in the attached letter, they are entitled to receive the payment for the supplement – independent and separate from the ongoing condemnation. Therefore, we are requesting the payment for the supplement since my client is in a worse situation than before due to that non-payment.
