


He said that it did not run, and he would have someone tow it. He may have the move completed as a actual cost move. |
| | I told him that if he needed to do a actual cost move that he would need to get me 2 estimates and that I would need to have that move approved. He said that he would let me know. |
| 01-07-2022 | I spoke with Mr. Valles he said that he would try and have the motor home moved this weekend. He may do as an actual cost move. |
| 01-07-2022 | Wayne Valles called and said that he had moved the bus from Sam Bass Storage. |
| | Because the bus did not run, he had to hire a tow company to move to the new location. The cost of this was more than the fixed move so Mr. Valles elected to have the bus and him be reimbursed base off the actual costs. I received a paid invoice from the tow company and based on the size of the bus being moved and the need for a large tow truck to move the costs appears to be reasonable. |
