Dear Lt. Word,

Thank you for contacting me today. I appreciate the opportunity to discuss how Autoclear has improved its existing line of equipment. Your existing machine is a unibody machine. 1. It will make it easier for your officers to find threat items by identifying the shape of the item, where the older AutoMatAlert would only hit on atomic number, mass and density, meaning most knives were not found.
2. When used in conjunction with AutoMatAlert, the AI will take a false alarm from AutoMatAlert and override it if the shape is not recognized. This has the effect of substantially reducing the number of false alarms that your older machines get.
3. It will find previously undetected items like ceramic knives.
4. AutoThreatAssist is backwardly compatible with the machines you purchased in 2021.
5. As new threat items are learned by the AI, your software will receive all of those upgrades for the life of the machine.

**Separate Graphics card** – many competitors still use integrated graphics. While it is cheaper to produce, integrated graphics steals processing power away from the CPU. Autoclear uses advanced NVidia graphics cards which contain their own processor, leaving your main processor plenty of power to operate other features

**Linux Operating System** – all of your other security systems run on Linux. Autoclear is one of only two companies that have made the effort to convert. Everyone else still uses Windows, with all of its known vulnerabilities.

**More room on top** - for your monitor and keyboard. An adjustable side mount is also available.

**Better Cable Protection** – all of the cables safely protected inside the machine

**Automatic Seasoning** – if an x-ray machine sits without being used for a while, the generator may require seasoning. This used to be a technicians job. The new DVS technology will season itself, saving the cost of a service call.

**AutoMatAlert** – has been improved and is the first step in AI.

**Image Archiving** – easily done with a flash drive that is integrated directly into the Control Panel.



#### **SPECIAL TERMS**

- No Waiver of Sovereign Immunity or Powers: Nothing in this quote/agreement will be deemed to constitute a waiver of sovereign immunity or powers of customer, the Williamson County Commissioners Court, or the Williamson County Judge.
- Texas Prompt Payment Act Compliance: Payment for goods and services shall be governed by Chapter 2251 of the Texas Government Code. An invoice shall be deemed overdue the 31st day after the later of (1) the date customer receives the goods under the contract; (2) the date the performance of the service under the contract is completed; or (3) the date the Williamson County Auditor receives an invoice for the goods or services. Interest charges for any overdue payments shall be paid by customer in accordance with Texas Government Code Section 2251.025. More specifically, the rate of interest that shall accrue on a late payment is the rate in effect on September 1 of customer's fiscal year in which the payment becomes due.
