Video Surveillance System

KSS will furnish and install the following:

- KSS will install One new Exterior camera
 - One exterior corner mounted 4-lens camera
- Initial programming will include:
 - Configurations on existing functional archive server; System ID GSC-170814-368468
 - Enrolling the cameras and setting up basic motion detection
 - One administrative account
 - One view only account
 - Estimated days of storage 30
 - 8MP at H.265 and 10 FPS
 - Calculations are based on 40% motion detection or event recording

KSS will perform acceptance testing in the presence of the appointed Customer representative to ensure proper operation and communication of all integrated systems. The final system test report will be sent to all parties.
