# **Customer Theory of Operation:**

Stanley Security will be installing a New Access Card Control System at the Williamson County Expo Center. We are proud to have the opportunity to work at one of Williamson County's Crown Jewels and will insure to apply our exemplary professionalism to this project.

Stanley's NJPA Contract Number: 030421-SCS & the customers NJPA (Sourcewell) member ID# 9076 MSA approved in Commissioner's Court on 3/24/2020

The scope of this project has been Directed by the Williamson County Access Control Department. There is not a RFP for this project due to use of the Sourcewell contract.

The Wilco Access Control Department has provided plans showing the locations of the new card readers and the doors which they will be able to control with the Control System. This is a new Lenel Access Control System for this site and there are no existing doors.

It is understood that if the described scope needs to change due to unforeseen obstacles there may be additional cost for the customer. This cost would be based upon the additional need of Parts, Labor and the required Licenses/ permits. The current scope will not require permits or fees.

# Stanley to provided and install the following;

- Twenty-Two Doors will have a new Access Card Reader and a new electronic locking hardware for key areas thru out the Expo Center
- Stanley Security will be providing and installing the necessary cable from each card reader location to each of the headend control panels With Batteries as noted on parts list.) Customer to provide any needed power requirements for the control panels.
- There will be Four headend control panels located in key areas of the building having the card readers.
- Each headend control panel (Locations shown on the plans) will communicate via the Wilco IT network to the main Wilco
- All cable will be sleeved within conduit for stub ups to the existing drop ceiling and continued conduit for the open ceiling areas.
- Colored Conduit will be used in the open areas in the Main Building Athletic/ Event Center area.
- Wireless Communication will be used to facilitate the Panel to Panel connection between the main Ticket
  and front Concessions Buildings. Using a wireless communicator eliminates the need for an additional IT
  drop and the cost of underground conduit installation.

Stanley will be trimming out and programming the new doors/ headend control panels as per Wilco standards. All electrical Conduit will be run by Big State Electric. Upon completion, Big State will provide As-built digital drawing showing pathways in PDF format. Hole Coring will be done by Big State Electric. All electronic Locking hardware will be installed by Bentley Lock.

If any locks require local power, that this will be the responsibility of the county to provide a 110v power outlet near the door.

Any work outside of this scope will require a change order.
