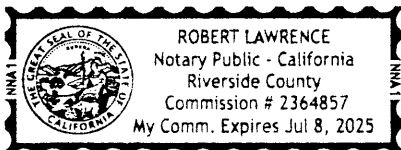




This letter of recommendation is being submitted for the purchase approval of the Bosch CDR. This tool is essential to the duties of the Crash Reconstruction Unit. The device is used to read the computers of the vehicles involved in crashes in which they work. It allows the investigator to use vehicle data to determine the vehicle's speed, braking conditions, and much more. This data is used to verify crash reconstruction reports. There are no comparable devices on the market that I could locate and there are no other companies that sell the Bosch CDR besides Crash Data Group out of Canada.

This is the same device that is also used by five agencies within our county for the same purpose. It not only allows us to run consistent investigations with these agencies, but it also provides our District and County Attorney's Offices with the best cases possible to pursue criminal charges. It also allows us to use the tool as a force multiplier because every agency has different vehicle cables. This allows us to have a vast variety of vehicle cables available to each agency without having to purchase every vehicle cable ourselves.
