The budget above totaling \$388,224.73 is the expected funding required to operate a 12-bed facility including staffing for a 12 month period of time. The budget items above are calculations using 40% of our 2022 actual budget expenses from our 30-bed facility. Hope Alliance is requesting the use of the county-owned facility for an auxiliarty emergency shelter. Additionally, Hope Alliance is requesting funding for a 6-month period of time, or ½ of the total above, or \$194,112.36 beginning on April 1, 2023 and ending on September 30, 2023.

Should the County approve our request, then Hope Alliance will request 12 months of funding from VOCA to operate the Temporary Auxiliary Emergency Shelter from October 1, 2023 to September 30, 2024. However, the deadline for submitting the VOCA Grant Application is February 9, 2023.

If both funding requests are approved, then Hope Alliance expects to serve a total of 180 victims of Domestic Violence and or Sexual Assault during the 18 month period. During the same time, Hope Alliance expects to be able to fund a total of 6,600 Sheltered Nights of Safety.
