Reason for Change

This Change Order adds new pay items to reimburse the contractor for required street signs and pavement markings that were not shown in the original plans. This Change Order also adds an item for a clearance sign that was shown in the plans but had no pay item to pay for the work. In addition, this Change Order adds a pay item to reimburse the contractor for ground boxes not installed. The original plans called for 18 ground boxes but only 12 were needed. The contractor ordered and received the Type "D" ground boxes prior to changes in the field being made. The contractor will deliver the 6 additional ground boxes to the Williamson County Maintenance yard.

1. CONCRETE COVER DIMENSIONS ARE CLEAR DIMENSIONS UNLESS NOTED OTHERWISE. REINFORCING BAR DIMENSIONS ARE OUT-TO-OUT OF BAR.
2. PROVIDE CLASS C CONCRETE ($f'c = 3,600$ PSI).
3. PROVIDE GRADE 60 REINFORCING STEEL.
4. PROVIDE ASTM A500 GRADE C HSS SECTIONS.
5. ALL PARTS SHALL BE HOT-DIPPED GALVANIZED AFTER FABRICATION IN ACCORDANCE WITH ITEM 445, "GALVANIZING". ALL WELDED CONNECTIONS SHALL OCCUR PRIOR TO GALVANIZING. PROVIDE VENT AND DRAIN HOLES AS NECESSARY FOR ADEQUATE FLOW OF GALVANIZING MATERIAL TO ENSURE A COMPLETE COATING OF ALL INTERIOR AND EXTERIOR STEEL SURFACES.
