Texas Health and Safety Code

- ▶ [Texas Health and Safety Code, Title 2, Subtitle C, Chapter 61: Indigent Health Care and Treatment Act](#)
 - ▶ Chapter 61 created in September of 1989
 - ▶ Identifies the responsibilities of the department, counties, hospital districts, and public hospitals.
 - ▶ Identifies health care services for eligible population.
- ▶ [Texas Administrative Code, Title 26, Part 1, Chapter 363](#)
 - ▶ Establishes the County Indigent Health Care Program (CIHCP) rules regarding program administration, required documentation, determining eligibility, and providing services.



Health Care Services

Basic Services

According to Health and Safety Code Section 61.028, counties shall provide these health care services.

Physician services

Annual physical examinations

Immunizations

Medical screenings

Inpatient & outpatient hospital services

Rural health clinics

Laboratory and x-ray services

3 prescriptions per month

Skilled nursing facility services

Additional Services provided by Williamson County

- ▶ Mental Health Services include:
 - ▶ 30 Outpatient visits
 - ▶ Inpatient care in acute hospital or psychiatric hospital
 - ▶ Services payable to MD, Ph.D, Clinical Psychologist, Licensed Clinical Social Worker, Licensed Professional Counselor, Licenses Marriage & Family Therapist
- ▶ Emergency Services include:
 - ▶ In and out of area
 - ▶ Urgent care in and out of area
- ▶ Dental Services include:
 - ▶ Samaritan Health Ministries
 - ▶ Sacred Heart Clinic



Program Eligibility

Eligibility Standards & Rules

- ▶ According to [Texas Health and Safety Code, Title 2, Subtitle C, Chapter 61: Indigent Health Care and Treatment Act](#)
 - ▶ Documentation is required for determining eligibility for the program.
 - ▶ Documentation is to be requested once an application is received.
 - ▶ All documentation is stored according to guidelines for a minimum of 3 years.
 - ▶ Audits are conducted annually by Williamson County to ensure all codes are followed.
 - ▶ Internal audits are conducted monthly for program efficacy.
 - ▶ Documentation is used for reimbursement of Medicaid services once an individual is approved for SSI.

WilCo Care Eligibility - Criteria

Lives in Williamson County.

18 years of age or older.

Has an income level at or below 21% of the current federal poverty guidelines.

Countable resources less than \$2,000.

A Social Security Card.

Is not eligible for Medicaid.

Monthly Income Standard Based on March 2023 Federal Poverty Level

A household is eligible if its monthly net income, after rounding down cents, does not exceed the monthly income standard for the CIHCP household's size.








