TLIE provides a claims-made policy which offers prior acts coverage for judicial-related claims, subject to the terms and provisions of the policy. Since there is a prior knowledge exclusion in the policy (see Article 3.10 of the specimen policy), if you are aware of any circumstance, act, error or omission which you believe might result in a future claim, you should immediately report the matter to your current insurance carrier. We suggest that you report the matter even if you believe that the potential claim would be frivolous or unjustified, in order to protect yourself.
