Dear Ms. Hancock,

Please find attached the bid tabulation for the subject-referenced project. The bids have been reviewed and the apparent low bid (Smith Contracting) was found to be responsive and materially balanced. Following is a summary of the bid totals:

1.	Smith Contracting	\$1,748,938.75
2.	Aaron Concrete Contractors, LLC	\$2,013,402.53
3.	Chasco Constructors	\$2,097,962.55
4.	Joe Bland Construction, L.P.	\$2,363,083.00
5.	Gage and Cade Construction	\$3,023,892.61

The lowest bidder was \$529,969.75 lower than the Engineers Estimate, a cost savings of 23.3%. The bidding was competitive with the lowest two bidders being within 15.1% of each other.

In addition to meeting the bid qualifications subject to being the low bidder, Smith Contracting has successfully completed past projects for Williamson County including Wyoming Springs Intersection Improvements at Smyers Lane, CR 200 Reconstruction, Neenah Avenue Widening project and the Lakeline Blvd. Right Turn Lane. Based on the quality of work performed by the Contractor and favorable working relationship with the County and its Representatives, we therefore concur with the recommendation of the Design Engineer, RTG, for award of the CR 138 Right Turn Lane at SH 130 construction contract to Smith Contracting in the amount of \$1,748,938.75.

On December 19, 2023, contractor bids were submitted and opened for the above referenced project. We have reviewed the bids and a summary of the contractor bid amounts is as follows:

1.	Smith Contracting	\$ 1,748,938.75
2.	Aaron Concrete Contractors, LLC	\$ 2,013,402.53
3.	Chasco Constructors	\$ 2,097,962.55
4.	Joe Bland Construction, L.P.	\$ 2,363,083.00
5.	Gage and Cade Construction	\$ 3,023,892.61

A detailed bid analysis was previously provided and reviewed by Rodriguez Transportation Group. The bids ranged from 23.3 percent below to 32.7 percent over the Engineer's Estimate. There were no errors detected, mathematical or otherwise, that would require disgualification of any of the bidders. Smith Contracting submitted the lowest bid in the amount of \$ 1,748,938.75 at 23.3 percent below the Engineer's Estimate.

Based on the low bid amount, we recommend that Smith Contracting be awarded the contract. Please let us know if you have any questions.
