
AMENDMENT TO WILLIAMSON COUNTY RENTAL AGREEMENT

(Safeware, Inc.)

THIS AMENDMENT TO WILLIAMSON COUNTY RENTAL AGREEMENT (hereinafter “Amendment”) is made and entered into by and between **Williamson County, Texas** (“County”), a political subdivision of the State of Texas, acting herein by and through its governing body, and **Safeware, Inc.** (hereinafter “Vendor”), both of which are referred to herein as the parties.

RECITALS

WHEREAS, the County and Vendor previously executed a Williamson County Rental Agreement (the “Agreement”), effective on November 2, 2023, wherein Vendor agreed to lease equipment for a term of four year beginning on November 1, 2023 and ending on October 31, 2027;

WHEREAS, County desires to amend the lease term;

NOW, THEREFORE, premises considered, the Parties agree that the Agreement is amended as follows:

AGREEMENT

- I. Section II, Term, of the Agreement shall be amended as follows:

Term: The Vendor agrees to lease the goods described in Exhibit “A” for a term of four (4) years beginning on April 1, 2024 and ending on March 31, 2028.

- II. Each party represents and warrants that it has due power and lawful authority to execute and deliver this Amendment and to perform its obligations under the Agreement; and furthermore, the Agreement and this Amendment are the valid, binding, and enforceable obligations of such party.
- III. All other terms of the Agreement which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this Amendment to be signed by their duly authorized representatives on behalf of such party, to be effective as of the date of the last party’s

execution hereof.
