## **EXPLANATION:**

- 1. Replace existing 60A 3PH panelboard with new 42 circuit panelboard, 3PH 4W MCB 200A rated
- 2. Reconnect existing circuits with new breakers. Old panelboard returned to Williamson County
- 3. Replace existing 15 kva transformer with new 75 kva transformer 480 3PH primary to 208/120 4W 3PH
- 4. Bond to building steel and main EMSB
- 5. Increase feeder to Panel ELA-S1 to 1 1/4" EMT with 4-#6THHN, 1-38GR.
- 6. Increase feeder to transformer with 1 1/2" EMT C with 3-#2 THHN 1-#8G
- 7. Demo existing fan control 120V wiring and pipe to roof.
- 8. Reroute 4-flue pipes to top of roof per owner request instead of across the garage and out the side wall.
- 9. Pipe/valves/fittings for the following systems: Flue pipe to be in DuraVent PolyPro pipe and fittings
- 10. Domestic water to be in type L copper pipe and fittings. Some press fittings may be used to keep downtime on the system to a minimum
