PROFESSIONAL SERVICES AGREEMENT
FOR DENTAL SERVICES AT THE
WILLIAMSON COUNTY JAIL**

THIS ADDENDUM TO PROFESSIONAL SERVICE AGREEMENT is made and entered into by and between **Williamson County, Texas** (hereinafter "County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and **Todd C. Harris, P.C.** (hereinafter "Provider"), with offices at 1600 W. 38th St., Ste. 305, Austin, TX 78731. The parties originally entered into an Agreement on April 7, 2009, which has been previously amended and extended. Provider is engaged as an independent contractor, to assist in providing certain operational services pursuant to the following terms, conditions, and restrictions:

I.

Term: This amendment will renew this Professional Services Agreement for an additional one (1) year term and continue until September 30, 2023.

II.

Cost and Payment: This amendment will revise the compensation cap set forth in the original agreement (under paragraph III) to a monthly amount of eight thousand two hundred eight dollars and thirty-three cents (\$8,208.33) and a yearly not-to-exceed amount for fiscal year 2023 (October 1, 2022 to September 30, 2023) of **ninety eighty thousand five hundred dollars and zero cents (\$98,500.00)**.

III.

In all other respects, the Agreement is reaffirmed.


