Thank you for your participation in the Williamson County Regional Habitat Conservation Plan (RHCP). The following determination of fees relates to the referenced project area as a condition of participation under the Plan. A review of the application and supporting documents has been conducted in accordance with the RHCP. The fee for participation under the RHCP for the referenced project will be \$192,750.00 (One Hundred Ninety-two Thousand Seven Hundred Fifty and No Hundredths Dollars) representing the approximate 2.0 acres of direct impacts to Golden-cheeked warbler habitat assessed at \$15,000/acre and 21.7 acres of indirect impacts to Golden-cheeked warbler habitat assessed at \$7,500/acre. Other impacts to listed species are covered by the incidental take statement issues under consultation with the US Fish & Wildlife Service under project 2024-0020457.
