WILLIAMSON COUNTY ROAD BOND PROJECT: CR 314 Safety Improvements (IH 35 to CR 332)

This Supplemental Work Authorization No. <u>03</u> to Work Authorization No. <u>07</u> is made pursuant to the terms and conditions of the Williamson County Contract for Surveying Services, being dated <u>May 13, 2024</u> ("Contract") and entered into by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and **Austin Survey Company, LLC dba Inland Geodetics** (the "Surveyor").

WHEREAS, the County and the Surveyor executed Work Authorization No. <u>07</u> dated effective <u>July 18, 2024</u> (the "Work Authorization");

WHEREAS, pursuant to Article 14 of the Contract, amendments, changes and modifications to a fully executed Work Authorization shall be made in the form of a Supplemental Work Authorization; and

WHEREAS, it has become necessary to amend, change and modify the Work Authorization.

AGREEMENT

NOW, THEREFORE, premises considered, the County and the Surveyor agree that the Work Authorization shall be amended, changed and modified as follows:

- I. The Services to be Provided by the Surveyor that were set out in the original Attachment "B" of the Work Authorization are hereby amended, changed, and modified to show an increase in the total parcel acquisitions by 6 additional parcels, from 91 parcels to 97 parcels of Item d, Parcel Acquisition Documents, due to modifications during negotiations in the previously established right-of-way (ROW) footprint. All changes and additions to services provided will be shown in the revised Attachment "B" (must be attached).
- II. The Work Authorization shall terminate on **September 30, 2025**. The Services to be Provided by the Surveyor shall be fully completed on or before said date unless extended by an additional Supplemental Work Authorization. The revised Work Schedule is attached hereto as Attachment "C" (must be attached).

III. The maximum amount payable for service under the Work Authorization is hereby increased by \$41,850.00 from \$202,075.00 to \$243,925.00. The revised Fee Schedule is attached hereto as Attachment "D" (must be attached).

Except as otherwise amended by prior or future Supplemental Work Authorizations, all other terms of the Work Authorization are unchanged and will remain in full force and effect.

This Supplemental Work Authorization does not waive the parties' responsibilities and obligations provided under the Contract.

PROJECT AMENDMENT

PROJECT SCOPE

This amendment hereby increases the Parcel Acquisition Documents services by **six (6)** parcels, from 91 parcel acquisitions to an amount not to exceed 97 parcel acquisitions, along CR 314, from IH 35 to CR 332. Surveyor's Scope of Services is limited to those items outlined below.

 - After receipt of title commitments, set appropriate monumentation in accordance with County requirements. Prepare signed and sealed documents for ROW parcel and easement acquisition(s).
 - Stake proposed ROW with suitable markers as requested, on a parcelby-parcel basis, for the purposes of fence construction, utility installation, or property owner requests.
