This Amendment No. 1 to Supplemental Agreement No. 2 to the First Amended and Restated Agreement For Planning, Design & Engineering Services ("Amendment No. 1") is by and between **Williamson County**, a body corporate and politic under the laws of the State of Texas ("County") and A/E.

RECITALS

WHEREAS, County and A/E previously executed that certain Agreement for Planning, Design and Engineering Services ("Agreement") being dated effective August 5th, 2020, wherein A/E agreed to perform certain professional planning, design and engineering services in connection with the Project;

WHEREAS, County and A/E thereafter executed that certain First Amended and Restated Agreement for Planning, Design and Engineering Services being dated effective December 8, 2021;

WHEREAS, County and A/E thereafter executed that certain Supplemental Agreement No. 2 to the First Amended and Restated Agreement for Planning, Design & Engineering Services, being dated effective February 27, 2025 in order to add additional services, fees, and time for completion of such additional services ("Supplemental Agreement No. 2");

WHEREAS, the parties wish to amend the language relating to the **Production Schedule** under **Exhibit C** of Supplemental Agreement No. 2; and,

PSA Amendment Form rev. 03/2025 **WHEREAS,** it has become necessary to supplement, modify and amend Supplemental Agreement No. 2 in accordance with the provisions thereof.

NOW, THEREFORE, premises considered, County and A/E agree that Supplemental Agreement No. 2 is supplemented, modified and amended as follows:

All other terms of the Agreement, Supplemental Agreement No. 2, any prior Supplemental Agreements, and amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.
