SECOND AMENDMENT TO WILLIAMSON COUNTY SERVICE AGREEMENT

THIS SECOND AMENDMENT TO WILLIAMSON COUNTY SERVICE AGREEMENT ("Second Amendment") is entered into as of the last party's execution hereof, by and between Williamson County, Texas ("County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and Heart of Texas Landscape & Irrigation Co. ("Service Provider"), both of which are referred to herein as the parties.

WHEREAS, the County and Service Provider entered into a Service Agreement, RFP T1289 Parks Landscaping, dated effective October 1, 2020 (the "Agreement"), setting forth the terms and conditions pursuant to which Service Provider agreed to provide certain services;

WHEREAS, the Parties desires to amend the Agreement to include an additional location to the scope of service.

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

AMENDMENT

- I. Section 1.6. <u>Landscape Specifications</u> of the Agreement shall be amended to include the West Arena at the Williamson County Expo Center as described in the attached Proposal being marked as Exhibit A.
- II. The additional location for landscaping is deemed to be in the public's interest and incorporated into the Agreement as follows:
 - Landscape of the West Arena at the Williamson County Expo Center by Service Provider in the amount of \$5,294.00, per fiscal year. For purposes of this Second Amendment, the County's fiscal year shall be October 1st to September 30th.
- III. Each party represents and warrants that it has due power and lawful authority to execute and deliver this Second Amendment and to perform its obligations under the Agreement; and, furthermore, the Agreement and this Second Amendment are the valid, binding, and enforceable obligations of such party.
- IV. All other terms of the Agreement which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this Second Amendment to be signed by their duly authorized representatives on behalf of such party, to be effective as of the date of the last party's execution hereof.
