Describe the purpose of the grant in detail to include all requirements.	Twice a year LCRA awards up to \$50,000 for capital improvement projects that benefit an entire community. A few of the program areas that are eligible are fire departments, recreation, community planning, education, public safety lifesaving equipment, and an organization or project affected by a disaster. Williamson County EMS intends to apply for grant to purchase a Swift Water Rescue Boat. EMS currently has 14 staff trained in swift water rescue and often assists the Sheriff's office in emergency situations. Having an additional boat within the county would bolster preparedness and provide for quicker response. Requirements of the grant include a 20% match for amounts great than \$5,000. The entity/community applying must be within a LCRA service area The deadline for grant applications is July 31, 2025.

The Sheriff's office has two swift water boats, however during an emergency it is not uncommon to have a need for six or more boats. EMS staff trained in swift water rescue have been supplementing the Sheriff's office and aiding in swift water rescue for the last 20 years.
How is this item request different from any similar assets currently in the County and/or region?	This request would add an additional swift water recuse boat to the County and will be a force multiplier in the event of any water rescue scenario.
What types of events/purpose would this item be used for that cannot be accomplished with a current County asset?	Even moderate flooding events can require multiple resources at one time; this swift water rescue boat would provide more coverage within the County and dramatically reduced response time and increase coverage area for rescues.
Identify the number of personnel required to operate this item and/or be available for the function where it is to be used?	EMS currently has 14 staff members trained in swift water rescue.

Where will the item be stored?	It will be stored under protected cover at the EMS Administration and Training Facility at 3189 S.E. Inner Loop, Georgetown, TX.
What is the useful life of the item?	The inflatable part of the boat is the most vulnerable but should last 4-8 years. The remaining parts of the boat to include motor and trailer have a longer life expectancy of 10+ years.

Having this additional capability along with swift water rescue trained providers will allow us to help regionally and even across the State to help any Texans in need. As mentioned previously, this asset is a force multiplier when disaster strikes.
