

FUNDING TERMS AND CONDITIONS for DISASTER RELIEF GRANT to:
Williamson County Regional Animal Shelter

The granting of funds from VCA Charities is subject to the below terms and conditions.

1. Recipient acknowledges that a grant of \$8110.63 has been approved by VCA Charities to Williamson County Regional Animal Shelter for expenses due to the emergency response to the Central Texas Flooding of July 2025. This grant is for the costs associated with the sheltering medical care, and transport of displaced animals and includes \$4250.00 in cash funding and \$3,860.63 in in-kind supplies (kennels, microchip scanners, leashes, collars, and halters).
2. Recipient will assume total liability for the products purchased through this grant. Recipient hereby waives any claims against, and agrees to release VCA Charities and its officers, directors, agents and employees, from any and all liability, damage, expense, cause of action, claim, judgment and cost of defence (including reasonable attorney's fees, if awarded by a court of competent jurisdiction) arising out of or relating to this grant.
3. If, for some reason the Recipient's organization is unable to proceed with the funded project, the Recipient's organization must inform VCA Charities in writing as soon as possible and immediately repay the funding amount received.
4. Any variation to the project, as detailed above, must be agreed to in writing by VCA Charities.
5. VCA Charities understands and supports Recipient publicizing receipt of grants to its communities via news releases, newsletters, organization's website, Facebook, etc. Recipient agrees to provide VCA Charities the opportunity to preview and edit material prior to release. Recipient is encouraged to send VCA Charities digital photos and stories of pets and people helped through VCA Charities' grants. Recipient authorizes VCA Charities, Medical Management International, Inc. (MMI), and/or VCA Animal Hospitals to share these photos and stories on its print, digital and/or other media, and acknowledges such possible sharing. Recipient represents and warrants that it has obtained a release, for each photo and story provided, that permits VCA Charities, MMI and VCA Animal Hospitals to use the photos and stories submitted in print, digital, or other media, and Recipient agrees to indemnify and hold harmless VCA Charities, MMI, and VCA Animal Hospitals from any claims that their use of the photos or stories violates or infringes the intellectual property, privacy, or publicity rights of any third party.
6. Grant funding must be expended by the end of the grant term, January 31, 2026, at which time a final report is due. Reference Final Report Form provided. Report should include any promotional materials or media releases concerning the funded project, and photos (high-resolution) are strongly encouraged.
7. If the recipient breaches any of these terms and conditions, VCA Charities reserves the discretionary right to reclaim in part or in whole the funding.
