



Mightycat Grant Terms and Conditions

The granting of funds from Orphan Kitten Club ("OKC") to **Williamson County Regional Animal Shelter** ("Recipient") is subject to the below terms and conditions.

1. Recipient acknowledges a grant of **emergency funds** from OKC for the purposes of crisis and disaster relief.
2. Recipient agrees to submit a follow-up report 30 days after funding and at 10-months to collect data on overall impact. Recipient will receive a reminder 2 weeks and 1 day before each report is due. Reports must be submitted on time. Recipient understands that failure to submit a timely report is a breach of contract and may result in reclamation of part or whole of the funding.
3. Recipient is required to send OKC 3-5 high quality digital photos kittens (0-12 weeks old) being supported by the emergency funds. Recipient authorizes OKC and Kitten Lady LLC to share these photos, stories and data on its print, digital and/or other media, and acknowledges such possible sharing. Recipient represents and warrants that it has obtained a release, for each photo and story provided, that permits OKC and Kitten Lady LLC to use the photos and stories submitted in print, digital, or other media, and Recipient agrees to indemnify and hold harmless OKC and Kitten Lady LLC from any claims that their use of the photos or stories violates or infringes the intellectual property, privacy, or publicity rights of any third party.
4. Recipient agrees to publicize the grant on social media. Recipient may also publicize the grant in news releases, newsletters, and website. Recipient agrees that any media outreach will be inclusive of the OKC press release, and agrees to give OKC an opportunity to review the final release in advance of media outreach.
5. Recipient agrees to include OKC logo on website.
6. If Recipient breaches any of these Terms and Conditions, OKC reserves the discretionary right to reclaim in part or in whole the funding.
7. In consideration of the grant memorialized herein, Recipient hereby waives any claims against, and agrees to release, indemnify, and hold harmless, OKC and its officers, directors, agents and employees, from any and all liability, damage, expense, cause of action, claim, judgment and cost of defense (including reasonable attorney's fees) that may result from handling, storage, use or misuse of the funding.
8. Recipient shall not make any oral or written statement about OKC which is intended or reasonably likely to disparage OKC and its officers, directors, agents and employees.



The parties agree that under the Constitution and laws of the State of Texas, the County cannot enter into an agreement whereby the County agrees to indemnify or hold harmless another party; therefore, all references of any kind to the County defending, indemnifying, holding, or saving harmless for any reason are hereby deleted.
