
**AMENDMENT TO
WILLIAMSON COUNTY
SERVICES CONTRACT
SECURITAS TECHNOLOGY CORPORATION**

THIS AMENDMENT TO THE WILLIAMSON COUNTY SERVICES CONTRACT ("Amendment") is entered into as of the last party's execution hereof, by and between Williamson County, Texas ("County"), a political subdivision of the State of Texas, acting herein by and through its governing body, and SECURITAS Technology Corporation f/k/a STANLEY Convergent Security Solutions ("Service Provider"), both of which are referred to herein as the parties.

WHEREAS, the County and Service Provider entered into a Service Contract, dated effective September 17, 2024, Agenda Item #49 CC 9/17/2024 (the "Contract"), setting forth the terms and conditions pursuant to which Service Provider agreed to provide certain services;

WHEREAS, the Parties desire to amend the Contract to extend the Effective Date and Term due to lack of personnel; working on an additional project in the Jail and more testing needed on the new system before shutdown the existing system.

NOW THEREFORE, the Parties agree that the Contract is amended as follows:

AMENDMENT

I. Section II. **Effective Date and Term** of the Contract shall be amended as follows:

Effective Date and Term: This Contract shall be in full force and effect from the date of the last party's execution below and shall continue through September 30, 2025. Unless terminated sooner pursuant to paragraph IX, of the original Contract.

II. Each party represents and warrants that it has due power and lawful authority to execute and deliver this Amendment and to fulfil its obligations under the Contract; and, furthermore, the Contract and this Amendment are the valid, binding, and enforceable obligations of such party.

III. All other terms of the Contract which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this Amendment to be signed by their duly authorized representatives on behalf of such party, to be effective as of the date of the last party's execution hereof.
