

FIRST AMENDMENT TO
AMENDED AND RESTATED
WILLIAMSON COUNTY EXPOSITION CENTER
OPERATION AND USE AGREEMENT

THIS FRIST AMENDMENT TO THAT CERTAIN AMENDED AND RESTATED WILLIAMSON COUNTY EXPOSITION CENTER OPERATION AND USE AGREEMENT (“First Amendment”) is made and entered into by and between WILLIAMSON COUNTY, TEXAS, a political subdivision of the State of Texas ("Owner") and TAYLOR RODEO ASSOCIATION, INC., a not-for-profit Texas corporation ("TRA"). Owner and TRA may be collectively referred to herein as the “Parties” and individually as a “Party.”

RECITALS

WHEREAS, Owner and TRA executed that certain agreement entitled Amended And Restated Williamson County Exposition Center Operation and Use Agreement (the “Agreement”), which became effective as of February 25, 2025, for the operation and use of designated areas of the Williamson County Expo Center for specific events held by TRA;

WHEREAS, Owner and TRA wish to amend the Booked Event #2 Dates of the Agreement;

NOW, THEREFORE, premises considered, Owner and TRA agree that the Agreement is amended as follows:

AGREEMENTS

1. 2.3.1 Booked TRA Events. The Parties agree to amend the Booked Event #2 Dates under Subsection 2.3.1(b) as follows:

Year of 2025:	June 11, 2025 to June 14, 2025
Year of 2026:	June 25, 2026 to June 27, 2026
Year of 2027:	June 24, 2027 to June 26, 2027
Year of 2028:	June 22, 2028 to June 24, 2028
Year of 2029:	June 21, 2029 to June 23, 2029

2. Authority. Each party represents and warrants that it has due power and lawful authority to execute and deliver this First Amendment and to perform its obligations under the Agreement; and, furthermore, the Agreement and this First Amendment are the valid, binding and enforceable obligations of such party.

3. Extent of Amendment. All other terms of the Agreement and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

IN WITNESS WHEREOF, the parties hereto have caused this First Amendment to be signed by their duly authorized representatives on behalf of such party, to be effective as of the date of the last party's execution hereof.
