

**AMENDMENT TO
INTERLOCAL AGREEMENT BETWEEN WILLIAMSON
COUNTY AND THE CITY OF GRANGER, TEXAS REGARDING
THE FUNDING FOR THE WATER AND WASTEWATER
IMPROVEMENT PROJECT**

THIS AMENDMENT TO THAT INTERLOCAL AGREEMENT BETWEEN WILLIAMSON COUNTY AND THE CITY OF GRANGER, TEXAS REGARDING THE FUNDING FOR THE WATER AND WASTEWATER IMPROVEMENT PROJECT (“Amendment”) is made and entered into by and between Williamson County, Texas, and the City of Granger, both being political subdivisions of the State of Texas (collectively referred to as the “Parties” and individually referred to as a “Party”).

RECITALS

WHEREAS, the Parties executed that certain agreement entitled Interlocal Agreement Between Williamson County and the City of Granger, Texas Regarding the Funding for the Water and Wastewater Improvement Project (“Agreement”), which became effective as of March 25, 2025;

WHEREAS, significant construction challenges have resulted in cost overruns exceeding the City of Granger’s current capacity to fund the final change order required to complete the project;

WHEREAS, it has become necessary to amend the Agreement to increase the County Reimbursement amount;

NOW, THEREFORE, premises considered, the Parties agree that the Agreement is amended as follows:

AGREEMENTS

1. **Section 2** of the Agreement shall be amended as follows:

The County agrees to pay to the City, pursuant to the conditions stated herein, the costs related to the construction of the Project, up to and no more than \$944,119.70 (the “County Reimbursements”). The Project comprises of the Scope of Services, as set forth in Appendix A, and Project Budget, as set forth in Appendix B, which is attached hereto and incorporated as if copied in full.

2. Each Party represents and warrants that it has due power and lawful authority to execute and deliver this Amendment and to perform its obligations under the Agreement; and, furthermore, the Agreement and this Amendment are the valid, binding and enforceable obligations of such Party.
3. All other terms of the Agreement and any prior amendments thereto which have not been specifically amended herein shall remain the same and shall continue in full force and effect.

IN WITNESS WHEREOF, the Parties have caused this Amendment to be signed by their duly authorized representatives on behalf of such Party, to be effective as of the date of the last party's execution hereof.
