WHEREAS, the county acknowledges its obligation to pay an annual participation fee based on county population as established annually by the GSC; and







Senate Bill 204 was passed during the 76th Legislative R.S., and became effective September 1, 1999. This bill allows county officers, employees, or persons who are in the custody of the state, traveling on official county business to participate in the State Travel Management Program (STMP) contract airline fares program administered by the General Services Commission (GSC).

Enclosed is a copy of an analysis of the Fiscal Year 2001 contract airline fares that are valid from September 1, 2000, through August 31, 2001. These contract airline fares are also located on our web page:

The form of payment used to obtain the contract airline fares is a Bank of America (BOA), Central Bill Account (CBA) issued through the State Travel Management Program's (STMP) contract with BOA.

Also, enclosed is information to participate that includes instructions, the Resolution, Point of Contact (POC) form, and a participation fee schedule. The participation fees are based on the population size of the county and to request an invoice, please contact me at the number below.

Participation in this program does not eliminate your county from using other forms of transportation for official county travel or prisoner retrieval. However, using this program can provide great savings to your county's budget.

Also included are recommendation letters from counties currently participating in the STMP contract airline fares program. These letters includes cost savings realized by the county through participating in the travel program.

## **Instructions for Participation**

### **County Commissioner's Court:**

1. The County Commissioner's Court, of a county wishing to participate in the discount airline fare program, must submit an approved resolution to the STMP. The resolution:
  - a. authorizes a Texas county to participate in the STMP's discount airline fare program; and
  - b. acknowledges the County's obligation to pay the participation fee.
2. Complete the Point-of-Contact (POC) form, which authorizes an individual of the county to execute all functions of the program.
3. The executed resolution, the POC form, and participation fee must be submitted to:

### **STMP:**

1. Upon receipt of the approved resolution, completed POC form, and annual participation fee the STMP will send (either electronically or by mail) the County an application to open the Central Bill Account (CBA) from Bank of America (BOA). The CBA is the only form of payment accepted by the airlines to obtain the State of Texas contract airline fares.
2. The County may begin using the contract airline fares upon receipt of the CBA number issued by BOA.
3. Each County is responsible for reconciling and paying the CBA statement on a monthly basis.

My Fellow Sheriff,

I would like to take this opportunity to enthusiastically endorse and recommend to you the State Travel contract program. This program, administered by the Texas General Services Commission is now available to your department. The program is made available through a sliding scale membership fee, based upon population and will not exceed \$2,500.00. All membership fees are utilized to administrate the program.

Thanks to this program, the days of no notice, full fair air travel for prisoner transports are over. Sheriff's departments across our great state can now access affordable, efficient and much safer air transport, with up to a 60 % savings over our former full coach option.

My office worked diligently to get this program enacted into law during the recent 75<sup>th</sup> Legislative session. The legislation, known as House bill 255, made the present state travel contract program a reality and it has exceeded our expectations.

In the first year alone the contract has saved my department and my county tax payers \$ 88,469.00. (See attached) The savings represent a tremendous ability to stretch and maximize our prisoner retrieval and transport capability. It also allows my deputies an added logistical, time management and officer/public safety opportunity when transporting prisoners.

The staff at the General Services Commission have proved to be very customer service oriented and gracious. The project manager, B.J. Slack has been a delight to work with. ## Contract Airfares – Fiscal Year 2001

Contracts for FY 2001 State of Texas airfares have been awarded. These contracts are valid from September 1, 2000, through August 31, 2001.

*In accordance with GSC rules, these contracts may be used by a Texas county officer or employee, or persons who are in the custody of the state, who is traveling on official county business, provided that the county has elected to participate in the program that provides this service.*

Airlines contract with the State of Texas in order to obtain a greater percentage of the State's business. When travelers do not use the contract airline, the contract carrier does not receive an increase in business and may refuse to contract with the State in the future. Use of the airline contracts can save Texas counties an average of 60% off normal coach fares.

The following document lists the contract city-pairs in alphabetical order along with the contract airline and contract base fare. **The base fare does not include the Federal Excise Ticket Tax (including segment fees) or any other mandatory fees assessed by the airlines, airports and/or local governments.** The airlines may round the fares to the nearest dollar amount. However, the base fare must not be higher than the amount listed on this document. The fares are applicable in either direction between the city points listed. Attachment A describes contract rules and conditions.

## STATE OF TEXAS CONTRACT AIRLINE FARES (Fiscal Year 2001)

**September 1, 2000 - August 31, 2001**

The State of Texas contract airline fares for Fiscal Year 2001 were awarded on August 18, 2000, with an effective date of September 1, 2000. City pair listings are one-way, in alphabetical order, and applicable in both directions. Fares listed are **base fares only** and do not include the Federal Excise Tax (including segment fees and passenger facility charges) or any other mandatory fees assessed by the airlines, airports, and/or local governments.

The fare basis codes of "YCATX" and "QCATX" are used when booking State of Texas contract airline fares. A "QCATX" fare basis code indicates a market that is **capacity-controlled** by the airline with a limited number of seats available at the contract rate. These markets usually have commuter-type jet aircraft (50 or fewer passenger seats) connecting small locales to larger cities. Delta Airlines has 32 city pair listings that are "QCATX" (see table below).

### NOTICE

#### FISCAL YEAR 2002 CONTRACT AIRLINE FARE AWARDS (Effective September 1, 2001)

Current contract airfares for Fiscal Year 2001 expire on August 31, 2001, and the State Travel Management Program (STMP) is in the process of evaluating bid responses for the new fiscal year (FY2002) effective September 1, 2001. The new awards should be announced and posted on this Web site on or about August 10, 2001. Once the awards are announced, the airlines have 5 to 10 calendar days to load the fares onto their reservation systems before they can be booked.

If it is necessary to book a State of Texas business flight for travel beginning September 1, 2001, prior to the effective date of those awards, one of the following options may be used:

- \* Wait until the awards are announced for Fiscal Year 2002 to book future travel.
- \* Book the lowest available fare on the current contract vendor and ensure that any rules or restrictions associated with that fare will allow for a reservation change without any penalties or additional fees.
- \* Book a fully refundable fare with NO restrictions on the current contract and cancel the reservation and/or ticket when the awards take effect. Rebook the reservation with the new award using the YCATX or "\_CATX" fare basis code.

State Travel Management Program****Contract Airfare Rules and Conditions  
September 1, 2000 – August 31, 2001****Use/Eligibility**

In accordance with the General Services Commission travel rules, contract airline fares can be used by a Texas county officer or persons who are in the custody of the state while traveling on official county business.

Contract airline fares can **ONLY** be used for official county business travel. Contract airline fares **CANNOT** be used for personal travel. State contract airline fares are NOT for group travel (10 or more).

**Payment**

Contract airline fares can **ONLY** be purchased with the State's contract Bank of America MasterCard central bill account (CBA). The Bank of America CBA begins with a specific prefix that allows the contract airlines to determine if the traveler is eligible to receive the contract airline fares. **NO OTHER FORM OF PAYMENT IS ACCEPTED FOR STATE CONTRACT AIRLINE FARES.**

**Tickets**

Tickets may be purchased from travel agencies who have been approved by the Airlines Reporting Corporation (ARC), all member airlines of the ARC (where allowed by interline agreement), all travel agencies who have been appointed by the ARC, and contract airlines. When payment is with the CBA, the contract airline may verify the account number issued to a participating county through records available to the airline by Bank of America or telephone verification with Bank of America authorization department. Also, you may be requested to present one of the forms of identification listed below. **Due to security reasons, the airlines prefer tickets purchased using a CBA account are booked through a travel agency.**

**Forms of Identification**

If you change a contract airfare ticket, you may be asked to present identification as validation of your eligibility to the contract airline fares. The forms of identification accepted by the contract airlines are:

- County officer or employee ID;
- Sheriff deputy or juvenile probation office ID and felony warrant of prisoner being transported; or
- A letter, on county letterhead, signed by an executive officer of the county, authorizing the bearer as traveling on official county business and authorized to use state contract airline fares. Documentation must be detailed and include travel dates and flight information.

**Reservations**

To make reservations, contact your travel agency, or the airline direct. Be sure to identify yourself as a **State of Texas county officer/employee** and ask for the YCATX fare basis code to ensure you receive the State of Texas contract rate. Airlines have contracts with other governmental entities, so please **do not** just say you need the government rate. When your reservation is made, simply give the travel agency or the airline the CBA number and the ticket will automatically be charged to the CBA.

**Class of Service**

The fare basis codes of "YCATX" and "QCATX" have been established to identify the State of Texas contract fare on the contract airline. Reservations for YCATX can be made in the regular unrestricted Y or coach class of service. Reservations for QCATX must be made in the Q seat inventory. The Q inventory is capacity controlled and is applicable in city-pairs where a regional airline or "commuter" size aircraft is involved in whole or in part of the service.

**Penalties and Restrictions**

State of Texas contract airline fares are not subject to any restrictions or penalties. There are no time limitations for advance purchase of tickets, day or time of departure, length of stay, ticket cancellation or change charges, or other special purchase requirements.

**Additional Charges**

Fares DO NOT include Federal Excise Ticket Taxes (which also include segment fees), Passenger Facility Charges (PFCs) – taxes and fees imposed by airports and/or local governments – or any fees for special services such as prepaid ticket charges (PTAs).

**Matched Fares**

Airlines who did not receive the State's contract award in a specific city-pair may offer matched or lower "state rates". A matched fare or lower "state rate" is a fare that is only offered to a state or county traveler, not the general public. Use of these matched airfares is not recommended. When travelers do not use the contract airline fares, the contract carrier does not receive an increase in business and may refuse to contract with the State in the future.


