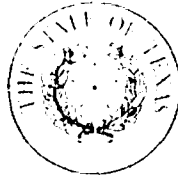

Description of Authorization:


