## CONTRACT FOR ENGINEERING SERVICES SUPPLEMENTAL AGREEMENT NO. 5 TO THE PROFESSIONAL SERVICES AGREEMENT

THIS SUPPLEMENTAL AGREEMENT to the Parmer Lane (Reagan Boulevard)
Professional Services Agreement for construction observer services is by and between
Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and
Haynie Consulting, Inc. (the "Engineer") and becomes effective when fully executed by both
parties.

WHEREAS, the *County* and the *Engineer* executed a contract on October 22, 2002:

WHEREAS, the not-to-exceed fee in Exhibit 1, Section 1, Item 1.1 of the agreement was increased with Supplemental Agreement No. 4 to \$803,317.50.

WHEREAS, the "Compensation Cap" in Exhibit 1, Section 4, Item 4.3 limits the maximum amount payable under the agreement and with Supplemental Agreement # 1, # 2, # 3 and # 4 is \$803,317.50; and,

WHEREAS, the Hourly Rates in Exhibit II are limited to the rates noted; and,

WHEREAS, it has become necessary to amend the agreement.

### AGREEMENT

NOW, THEREFORE, premises considered, the *County* and the *Engineer* agree that said contract is amended as follows:


- I. The not-to-exceed in Exhibit 1, Section 1, Item 1.1 hereby increased from \$803,317.50 to \$808,987.50.
- II. The Compensation Cap in Exhibit 1, Section 4, Item 4.3 is hereby increased from \$803,317.50 to \$808,987.50.
- III. The Hourly Rates in the original Exhibit II are hereby amended as shown in the attached revised Exhibit II.

All other provisions are unchanged and remain in full force and effect.
