Grantee acknowledges and stipulates that Grantee is not relying on any representation, statement, or other assertion with respect to the Property condition but is relying on Grantee's examination of the Property. Grantee takes the Property with the express understanding and stipulation that there are no express or implied warranties.

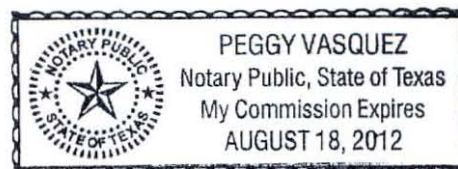

LEGAL DESCRIPTION FOR WILLRAE PARTNERS I, LTD.

BEING, 0.475 of an acre of land, situated in the Charles H. Delany Survey, Abstract No. 181, in Williamson County, Texas, said land being a portion of County Road No. 248. Surveyed on the ground in the month of September, 2008, under the supervision of Brian F. Peterson, Registered Professional Land Surveyor, and being more particularly described as follows;

Beginning for Reference at a broken concrete monument found on the north line of Farm to Market Highway No. 2338, marking the Southeast corner of that certain tract of land, called 132.42 acres, as conveyed to Willrae Partners I, Ltd., by deed recorded as Document No. 2004067447 of the Official Public Records of Williamson County, Texas;

THENCE, along The said north line of F.M. Highway No. 2338, being the south line of the said 132.47 acre Willrae Partners I, Ltd., tract, S 86°01'15" W, 124.78 feet to a concrete monument found marking a northwesterly corner of F.M. Highway No. 2338 and the Northeast corner of County Road No. 248, for the Northeast corner hereof;

THENCE, along a Westerly line of F.M. Highway No. 2338, S 03°55' E, 40.00 feet, to an iron pin set in the centerline and end of County Road No. 248, for the Southeast corner hereof;

THENCE, along the center of County Road No. 248, S 85°51'15" W, 283.51 feet, to an iron pin set;
S 87°32'30" W, 132.72 feet, to an iron pin set and N 89°00' W, 77.59 feet, to an iron pin set for the Southwest corner hereof;

THENCE, N 28°59'30" W, 54.75 feet, to an iron pin set on the north line of County Road No. 248, being the south line of the said 132.45 acre Willrae Partners I, Ltd., tract, for the Northwest corner hereof;

THENCE, along the north line of County Road No. 248, S 86°19'30" E, 101.34 feet, to an iron pin found;
N 89°05' E, 132.86 feet, to an iron pin found and N 85°42'45" E, 283.57 feet, to the Place of BEGINNING and containing 0.475 of an acre of land.


