

**ORDER ADJUSTING THE BOUNDARY BETWEEN
WILLIAMSON COUNTY ELECTION PRECINCTS 254, 273, 277 AND 293**

Currently Precinct 277 has 5,217 active registered voters. In accordance with section 42.006 of the Texas Election Code, Precinct 277 is not in compliance because it contains more than 5,000 registered voters. The county is authorized to make the change in the precinct boundary at this time by section 42.031(b)(2) of the Texas Election Code. The precincts affected by the boundary adjustments are 254, 273, 277, and 293, and graphically shown in the map contained in Exhibit "A," attached hereto and incorporated herein. The changes will result in Precinct 277 containing 3,896 active registered voters.


NOW, THEREFORE, BE IT ORDERED that the boundary adjustments shall be transferred and reassigned for each precinct effective January 1, 2010, and described, as follows:

- a. Precinct 254 will gain the northeast portion of current Precinct 277, east of South Lakeline Boulevard and north of West Park Street, thereby increasing the number of registered voters by 145 to 1,192. The polling place for this precinct remains Good Shepherd Lutheran Church, 700 West Whitestone Boulevard, Cedar Park. Exhibit "B" contains a written description of Precinct 254.
- b. Precinct 293 will gain the portion of current Precinct 277 east of South Lakeline Boulevard, south of West Park Street and north of Buttercup Creek Boulevard, thereby increasing the number of registered voters by 1,445 to 2,917. The polling place for this precinct remains Faubion Elementary School, 1209 Cypress Creek Road, Cedar Park. Exhibit "C" contains a written description of Precinct 293.
- c. Precinct 277 will gain the northern portion of current Precinct 273 that consists of the Cypress Creek Subdivision Sections 2 and 3, thereby reducing the number of registered voters in Precinct 273 by 269 to 2,204. The polling place for Precinct 277 remains Cedar Park High School, 2150 Cypress Creek Road, Cedar Park. The polling place for Precinct 273 remains Cypress Elementary School, 2900 El Salido Parkway, Cedar Park. Exhibit "D" contains a written description of Precinct 273. Exhibit "E" contains a written description of Precinct 277.

Election Precinct No. 254
Williamson County, Texas

BEGINNING at the intersection of North Lakeline Boulevard and West Whitestone Boulevard;

THENCE, easterly, along the center of West Whitestone Boulevard, to its intersection with the center of Southern Pacific Railroad;

THENCE, southerly, along the center of Southern Pacific Railroad, to its intersection with the center of West Park Street;

THENCE, westerly, along the center of West Park Street, to its intersection with the center of North Lakeline Boulevard;

THENCE, northerly, along the center of North Lakeline Boulevard, to the Place of the BEGINNING.

EXHIBIT C

Election Precinct No. 293
Williamson County, Texas

BEGINNING at the intersection of South Lakeline Boulevard and West Park Street;

THENCE, easterly, along the center of West Park Street, to its intersection with the center of Cluck Creek;

THENCE, southerly, along the center of Cluck Creek, to its intersection with the center of Banyon Cove;

THENCE, southerly, along the center of Banyon Cove, to its intersection with the center of Timber Trail;

THENCE, westerly, along the center of Timber Trail, to its intersection with the center of South Winecup Trail;

THENCE, southerly, along the center of South Winecup Trail, to its intersection with Oakridge Pass;

THENCE, southerly, along the center of Oakridge Pass, to its intersection with the center of Buttercup Creek Boulevard;

THENCE, westerly, along the center median of Buttercup Creek Boulevard, to its intersection with the center of Cactus Flower Drive;

THENCE, southerly, along the center of Cactus Flower Drive, to its intersection with the center of Rambling Trail;

THENCE, easterly, along the center of Rambling Trail, to its intersection with the center of Cluck Creek Trail;

THENCE, southerly, along the center of Cluck Creek Trail, to its intersection with the center of Cypress Creek Road;

THENCE, westerly, along the center of Cypress Creek Road, to its intersection with the center of South Lakeline Boulevard;

THENCE, northerly, along the center of South Lakeline Boulevard, to the Place of the **BEGINNING**.

EXHIBIT D

**Election Precinct No. 273
Williamson County, Texas**

BEGINNING at the intersection of the center of Dayflower Trace and the common line between Williamson and Travis Counties;

THENCE, easterly, along the center of Dayflower Trace, to its intersection with the center of El Salido Parkway;

THENCE, northerly, along the center of El Salido Parkway approximately 175 feet;

THENCE, easterly, approximately 990 ft;

THENCE, northerly, approximately 1200 ft, to the center of Sun Chase Boulevard;

THENCE, southerly, along the center of Sun Chase Boulevard, to its intersection the center of Old Mill Road;

THENCE, southwesterly, along the center of Old Mill Road, to its intersection with the center of Aster Pass;

THENCE, southerly, along the center Aster Pass, to its intersection with the center of Mesquite Road;

THENCE, westerly, along the center of Mesquite Road, to its intersection with the center of Little Elm Trail;

THENCE, southeasterly, along the center of Little Elm Trail, to its intersection with the center of North FM 620;

THENCE, westerly, along the center of North FM 620, to the common line between Williamson and Travis Counties;

THENCE, northerly, along the common line between Williamson and Travis Counties, to the Place of the **BEGINNING**.

EXHIBIT E

**Election Precinct No. 277
Williamson County, Texas**

BEGINNING at the intersection of the center of West Whitestone Boulevard and the common line between Williamson and Travis Counties;

THENCE, easterly, along the center of West Whitestone Boulevard, to its intersection with the center of South Lakeline Boulevard;

THENCE, southerly, along the center of South Lakeline Boulevard; to its intersection with the center of Cypress Creek Road;

THENCE, southwesterly, along the center of Cypress Creek Road, to its intersection with the center of Sun Chase Boulevard;

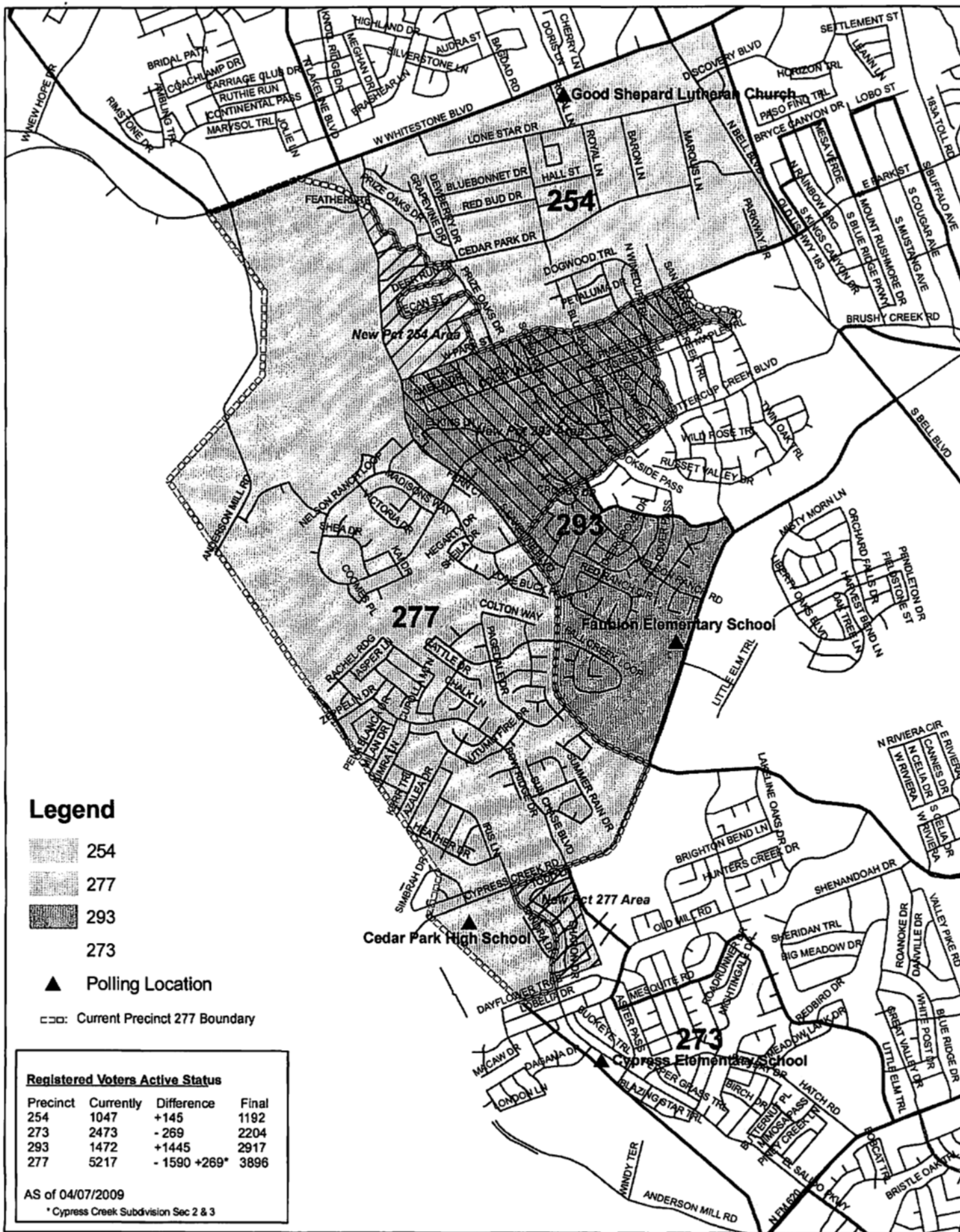
THENCE, southerly, approximately 2050 feet;

THENCE, southwesterly, approximately 1000 feet, to its intersection with the center of El Salido Parkway;

THENCE, southerly, along the center of El Salido Parkway, to its intersection with the center of Dayflower Trace;

THENCE, westerly, along the center of Dayflower Trace, to its intersection with the common line between Williamson and Travis Counties;

THENCE, northerly, along the common line between Williamson and Travis Counties, to the Place of the **BEGINNING**.
