ORDER CREATING WILLIAMSON COUNTY ELECTION PRECINCTS 402 AND 403

Precinct 426 has 5,027 active registered voters. Precinct 426 violates section 42.006 of the Texas Election Code because it contains more than 5,000 registered voters. Section 42.031(b)(2) of the Texas Election Code grants Commissioners Court the authority to make necessary changes in the precinct boundary.

After consultations with Commissioner Morrison, and the chairs of the Republican and Democratic parties, Bill Fairbrother and Richard Torres, recommendation is being made to adjust the boundaries to election precincts 420, 424, and 426 to create Precinct 402 and Precinct 403 as graphically displayed on the map entitled Exhibit "A," attached hereto and incorporated herein. The creation will result in the following active registered voter counts:

NOW, THEREFORE, BE IT ORDERED that, effective January 1, 2010:

Precinct 402 shall be created from the northwest portion of current Precinct 426 south of East US Highway 79, west of South Farm to Market Road 1660, following the current city of Hutto boundary to the State Highway 130. The precinct will also gain the northeast portion of current Precinct 424 following the current city of Hutto boundary. The polling place for Precinct 402 shall be Hutto City Hall, 401 West Front Street, Hutto. The polling place for Precinct 426 shall be Farley Middle School, 205 Swindoll Lane, Hutto.

Precinct 403 shall be created from the north central portion of current Precinct 426 south of East US Highway 79, east of South Farm to Market Road 1660, following the current city of Hutto boundary along the southeast and thence north to East US Highway 79. The precinct will also gain the portion of current Precinct 420 east of North Farm to Market Road 1660 following the currently city of Hutto boundary to the north and along the east. The polling place for Precinct 403 shall be Hutto Elementary School, 100 Mager Lane, Hutto. The polling place for Precinct 420 shall be Hutto Middle School, 1005 Exchange Boulevard, Hutto.





CREATION OF PRECINCTS 402 & 403 EFFECTIVE JANUARY 1, 2010





PRECINCT 402 EFFECTIVE JANUARY 1, 2010



PRECINCT 403 EFFECTIVE JANUARY 1, 2010



