## FIRST AMENDMENT TO THE WILLIAMSON COUNTY INDIGENT CARE AFFILIATION AGREEMENT

This First Amendment to the Williamson County Indigent Care Affiliation Agreement (the "First Amendment") is entered into this \_\_\_\_ day of August, 2009 to amend the Williamson County Indigent Care Affiliation Agreement (the "Agreement") dated June 24, 2008 by and among Williamson County, being a political subdivision of the State of Texas (the "County"), and Round Rock Medical Center (the "Affiliated Hospital").

## RECITALS

WHEREAS, the County and the Affiliated Hospital entered into the Agreement effective June 24, 2008.

WHEREAS, the Agreement was filed with the Texas Health and Human Services Commission ("HHSC") on August 28, 2008.

WHEREAS, HHSC requires that each participating hospital and county submit to HHSC a fully executed indigent care affiliation agreement on an annual basis in order to continue participating in the Williamson County UPL program during the following fiscal year.

WHEREAS, St. David's Georgetown Hospital merged into St. David's Healthcare Partnership effective November 1, 2008;

**WHEREAS**, the County and the Affiliated Hospital desire to amend the Agreement and file it with HHSC for the next fiscal year.

NOW, THEREFORE, the parties agree as follows:

1. The first paragraph of the Agreement shall be deleted and the paragraph below added in its place:

This Indigent Care Affiliation Agreement (the "Agreement") is entered into to be effective as of the 31<sup>st</sup> day of August, 2009 ("Effective Date"), by and between Williamson County, being a political subdivision of the State of Texas (the "County"), and Round Rock Medical Center (the "Affiliated Hospital"), whose address is listed in Section 6.3 of this document.

- 2. All references to "Affiliated Hospitals" shall be changed to "Affiliated Hospital".
- 3. All other terms and conditions of the Agreement shall remain unchanged and are fully incorporated herein by reference.
- 4. In executing this First Amendment, each party confirms, warrants and represents that all of that party's "Representations and Warranties" as set forth in the Agreement were, and continue to be, true and correct.
