

**ORDER APPROVING EARLY VOTING POLLING PLACES  
LOCAL OPTION ELECTION TO LEGALIZE THE SALE OF ALCOHOLIC  
BEVERAGES  
NOVEMBER 2, 2010**

On July 20, 2010, the Commissioners Court of Williamson County, Texas, approved the Early Voting Schedule as set forth in the Order for Local Option Election to Legalize the Sale of Alcoholic Beverages, said election being conducted on November 2, 2010 for registered voters in the City of Georgetown, Texas. Since that time, one of the temporary locations, Cedar Park Regional Medical Center, became unavailable and a request was received to add two temporary polling places in Georgetown and Liberty Hill. In the interest of serving the voters of Williamson County, the request to replace Cedar Park Regional Medical Center with Highland Estates Independent Retirement Living, both facilities being located in Cedar Park; and, the request to add two special temporary branch locations, Georgetown ISD High School Annex Cafeteria and Liberty Hill ISD Head Start Office, is hereby approved.

It is, therefore, ORDERED that Early Voting by personal appearance be conducted at the polling places and polling hours, as follows:


