

## CONTRACT FOR ENGINEERING SERVICES SUPPLEMENTAL AGREEMENT NO. 2 TO THE PROFESSIONAL SERVICES AGREEMENT

THIS SUPPLEMENTAL AGREEMENT to contract for engineering services is by and between Williamson County, Texas, a political subdivision of the State of Texas, (the "County") and Alba Consulting Inc. (the "Engineer") and becomes effective when fully executed by both parties.

WHEREAS, the County and the Engineer executed a contract on July 8, 2008;

WHEREAS, the not-to-exceed fee in Exhibit 1, Section 1, Item 1.1 limits the agreement to \$2,732,806.16 as amended by Supplemental Agreement No. 1; and,

WHEREAS, the "Compensation Cap" in Exhibit 1, Section 4, Item 4.3 limits the maximum amount payable under the agreement to \$2,732,806.16 as amended by Supplemental Agreement No. 1; and,

WHEREAS, the Hourly Rates in Exhibit II are limited to the rates noted; and,

WHEREAS, it has become necessary to amend the agreement.

#### **AGREEMENT**


NOW, THEREFORE, premises considered, the *County* and the *Engineer* agree that said contract is amended as follows:

- 1. The not-to-exceed fee in Exhibit 1, Section I, Item 1.1 is hereby increased from \$ 2,732,806.16 to \$ 2,982,806.16.
- II. The Compensation Cap in Exhibit 1, Section 4, Item 4.3 is hereby increased from \$ 2,732,806.16 to \$ 2,982,806.16.
- III. The hourly Rates in the original Exhibit II are not changed.

All other provisions are unchanged and remain in full force and effect.
