Re: Proposed Pre-Qualified Engineers List

We have reviewed the recent submittals for the Statement of Qualifications for Re-Certification of Engineering Firms for 2006 Road Bond Program – RFQ Number. 10WCRFQ1011. A total of 70 Letters of Interest or new Statement of Qualifications (SOQ's) were submitted. Of that number, 21 firms submitted qualifications that were not on the 2008 Pre-Qualified List approved by the Commissioners Court.

In addition to the new firms a number of the Statement of Qualifications addressed specific services (survey, geotechnical/testing/structural) as well as "additional services" including planning, traffic engineering, environmental and construction inspection.

All of the firms submitting in response to the RFQ addressed the minimum requirements. Many of the firms far exceeded the minimum requirements to provide engineering services for the Williamson County Road Bond Program.

We recommend that all of the firms on the attached list be forwarded to the Commissioners Court for consideration and approval as "Pre-Qualified". Firms on this list can then be considered by the Commissioners Court as it selects the firm best or most highly qualified to work on a specific project.

We recommend that this item be placed on the December 14, 2010 Commissioners Court Agenda. If you have any questions or need additional information let us know.
