To the Commissioners Court of Williamson County, Texas:

The undersigned, being qualified voters owning taxable real property within the proposed District, pursuant to Chapter 775.001, *et. seq.*, Texas Health and Safety Code, respectfully petition the Williamson County Judge and Williamson County Commissioners, for the establishment of the Williamson County Emergency Services District No. 11 (the "District").

In support of said petition, Petitioners would show the Commissioners Court the following:

1. That the District is to be created and is to operate under Article III, Section 48-e of the Texas Constitution and Chapter 775 of the Texas Health and Safety Code,
2. That the name of the proposed District is the Williamson County Emergency Services District No. 11,
3. That the boundaries of the proposed District are attached hereto and incorporated herein as Exhibit "A",
4. That the District will provide the following services;
 - a) Provide or contract to provide fire prevention services and other services as allowed in Chapter 775 of the Texas Health and Safety Code.
 - b) That the creation of the District complies with Sections 775.020 and 775.0205 of the Texas Health and Safety Code,
 - c) That at least 100 qualified voters residing within the proposed District have signed this Petition,
 - d) That prior to creation of the District, the City of Cedar Park must consent to the creation of the District, and
 - e) That this Petition includes an agreement by two petitioners to pay not more than \$150 of the costs incident to the formation of the District.
